The permittee hereby covenants and promises that, in consideration of the granting of this license and permit, the permittee shall release San Juan County, its County Council and County Engineer of and from all liability for damages to or the destruction of any property or equipment involved in the move as described above, irrespective of the manner in which such damage is caused, and agrees to release San Juan County, its County Council and the County Engineer and hold the same harmless from all liability for injury to or death to persons and the loss to or damage of personal or real property arising in any manner from the move described above, and in the event any action is instituted for a permittee's breach of the foregoing covenants to pay a reasonable attorney's fee to San Juan County as determined by the court and said action.

Permittee further covenants and promises that it assumes all liability for any damage or destruction of the county roads and the property of San Juan County and third parties located adjacent to County roadways. The permittee understands that it must furnish all necessary flares, barricades, signs, pilot cars and other safety devices necessary to comply with the motor vehicle laws of the State of Washington and to conform with the restriction noted below.

\_\_\_\_\_ Signs will be placed at the key intersections at least 48 hours prior to move if entire roadway is to be blocked.

\_\_\_\_\_ 2 Flaggers required for all house moves.

\_\_\_\_\_ **RED FLAGS** - All loads more than 8 feet wide must be adequately marked with red flags on all four corners of the load or reasonably close to said corners.

\_\_\_\_\_ **PILOT CARS** - Pilot cars must carry signs reading as follows: For front pilot car, "**OVERSIZE LOAD**" placed on the front of the pilot car. For the rear car, "**OVERSIZE LOAD**" placed on the rear of the pilot car. Pilot cars must lead or follow a load by at least 800 feet and not more than 1,500 feet.

\_\_\_\_\_ Maximum speed of 25 miles per hour.

\_\_\_\_\_ Daylight hours only. **NO** MOVEMENT IF VISION IS OBSCURED BY FOG OR INCLEMENT WEATHER

\_\_\_\_\_ Assume responsibility for overhead obstructions.

\_\_\_\_\_ Permittee further agrees to notify the San Juan County Sheriff, (360) 378-4151, or his deputy **at least 24 hours prior to the move** and to abide by any further restrictions that might be imposed by the Sheriff's office for safety purposes.

\_\_\_\_\_ No over-height vehicles/objects will be allowed on Mt. Baker Rd. from mile post 1 to mile post 1.24 (between Lovers Lane and North Beach Rd.) Without written approval from the Port of Orcas.

\_\_\_\_\_ No 12 ft. wide objects allowed beyond Moran State Park due to restricted physical clearance at the park entrance.

\_\_\_\_\_ **PERMITTEE SHALL CARRY THIS PERMIT IN THE TOW VEHICLE DURING THE MOVING OPERATION.**
