Canvassing Board Meeting Re: 2024 Primary Recount of Commissioner of Public Lands August 6, 2024, Primary Election

September 3, 2024 — Review

Auditor Warmenhoven called the meeting to order at 3:01 pm on Tuesday, September 3, 2024, at the San Juan County Elections office. Ms. Armstrong, Elections Manager, is not present at this meeting due to illness. Auditor Warmenhoven started with a summary of the recount that took place on September 27th and 28th.

The recount began by unsealing the ballot boxes. Ballots were split by island and then by precinct. The county is comprised of 23 precincts. Counting teams of four tackled the larger precincts while smaller precincts were addressed by teams of two. A total of 8,308 ballots were recounted within 10 hours. The results were identical to that of the initial election. No discrepancies.

Prosecutor Vira asked about how the ballots were counted. The ballot counters were not informed of the results prior to their count. If there was a discrepancy during the count, a second team would count that batch without being informed of the discrepancy. Each member of the team counted the ballots with the other members verifying their totals.


A representative from the Secretary of State was present at the recount to ensure all proper procedures were followed. Several observers also circulated throughout the day to observe the recount.

Auditor Warmenhoven read the oath of authenticity and signed the oath along with Councilperson Minney.


Auditor Warmenhoven read the certification of the canvassing board and signed this with all members of the canvassing board.


The meeting was adjourned by Auditor Warmenhoven at 3:12pm.
